The CAN-TECH Rising Star in Tech Law Award, presented annually, recognizes an outstanding [early career] member of the Canadian Technology Law Bar, [within their first ten (10) years of practice], for their achievements, ongoing service, and contributions in the following areas:

- developing and demonstrating leadership and innovation in the practice area;
- maintaining the highest standards of professional competence including integrity and civility; and
- commitment to the Technology Law Bar.

| Eligibility | Nominees must be a current CAN-TECH member in good standing, excluding current members of the Executive and Board of Directors, within their first ten (10) years of practice. |

| Presentation | The award will be presented at a CAN-TECH event. |
| Nomination Procedure | Nominations shall be solicited as follows: a request for nominations by way of email sent to all current members of CAN-TECH; social media promotion; a specific note in the CAN-TECH newsletter; and posted to the awards page of the CAN-TECH website. A CAN-TECH member in good standing is eligible to nominate a candidate by submission in writing of no more than two (2) pages double-spaced, together with the candidate's curriculum vitae, which shall outline the nominee's qualifications, and achievements in the area of information technology law. The nominator must indicate that the candidate has been advised of the nomination prior to the nomination deadline and consents thereto. Nominations are to be made by submitting the required documents using the online form by no later than September 22] each year. |
| Deadline for Applications | Nominations and supporting material must be filed online prior to a deadline to be set each year. |
